

Altru Prime by MedicaSM Fact Sheet

Overview

Altru Prime by MedicaSM is an accountable care system-based product offered in the Individual and Family Business (IFB) market in northeastern North Dakota and northwestern Minnesota. The network features Altru Health System doctors plus others. No referral is needed to see in-network specialists. Members do not have benefits for out-of-network providers.
