

## Medica Advantage Solution (HMO-POS) Fact Sheet

### Overview

The Medica Advantage Solution<sup>®</sup> (HMO-POS) product is governed by Centers for Medicaid and Medicare Services (CMS) rules and regulations. This is a Medicare Advantage product that utilizes a subset of the Medica Choice<sup>®</sup> provider network. Members get their Part A and Part B coverage from Medica Advantage Solution and not Original Medicare. Members enrolled in these plans also have coverage for most Medicare-covered services at out-of-network providers through the Point-of-Service (POS) benefit for an additional cost.

Medica Advantage Solution (HMO-POS) is offered through two plans that vary by coverage level and service area:

- Medica Advantage Solution (HMO-POS) H6154-001, which has coinsurance and copayments for some services available in the 7-county Twin Cities metro area
- Medica Advantage Solution (HMO-POS) H6154-002, which has coinsurance and copayments for some services available in the 6-county greater Twin Cities metro area

Members do not have the option to purchase optional riders. Part D benefits are included.

## Primary Health System (PHS)

Effective 1/1/21: Members enrolled in this plan may select a Primary Health System (PHS) from which to receive care. A PHS is a group of network doctors and health care professionals who can help manage a member's total health, from getting needed preventive screenings and care to coordinating care for multiple health conditions. Members may still get care from other in-network doctors and health care professionals at no additional cost and do not need a referral for covered services.

The member's PHS is identified on their Medica ID card just below their name.
