

Prevea360 West and Mayo Clinic Health System Provider Network

Overview

In conjunction with Medica's strategic partnership with its affiliate Dean Health Plan, Prevea360 (P360) has expanded its network offering for the State of Wisconsin — Prevea360 West and Mayo Clinic Health System — as of January 1, 2023.

This new network partnership offering in western Wisconsin has been created specifically to serve enrollees in the State of Wisconsin Group Health Insurance Program's Department of Employee Trust Funds (ETF), the health plan for state employees. Dean Health Plan/Prevea360 will be the claims administrator for this offering.
